## **B.** Discussion of County CCH Completeness report

The county completeness report was given. If your agency disposition rates are in yellow then you will need to be at 90% by Aug 1st.

# C. Discussion of approved FY19 Prioritization list for JAG, JJDP, VOCA, and VAWA

The sheets for each funding stream were given out as were presented to the Governor's Office. These listed the RBE Lines and the Quality Lines. The budgets were adjusted with the amounts that we knew had been changed already by the OOG.

JAG- These amounts are assuming all litigation is cleared up. The tope 12 will be funded with a partial amount to #12.

JJDP- The top 5 will be funded with a partial amount to #5. We asked BCFS if they could still fund the project even though it is not half the amount requested and they said yes. VAWA- The top 7 will be funded with a partial amount to #7. We do not know of any additional funding to be given.

VOCA- We do not know if any additional funding will be given. A clerical error was made in the scoring which resulted in BCFS being moved to #28. This resulted in multiple agencies moving below the RBE line. The top #28 will be funded with a partial amount to #28. The agencies for #34, #35 and #36 all sent a letter to the Governor's Office. They are wanting to have the liaison agencies in these rural areas be given a different funding source earmarked for them. #37 Our Lady of The Lake University is a continuation grant for transitional housing and were not aware of having to go through the COG process until Feb. The transitional housing projects should not come out of our RBE.

## D. Review and discussion of Scoring and Prioritization Process

There was discussion about changes that need to be made. Some changes discussed were:

- 1. Staff taking steps to delete previous years scoring so it does not get accidently included in current years.
- 2. Checking on a new software system that will calculate scores as you go.
- 3. Software set up so you do not have as many steps to get back into the next project to score.
- 4. Define the terms "Collaboration" and "Sustainability". What does CJD want to see? This will be discussed at next year's scoring training.
- 5. Ask agencies what they will do about their sustainability.
- 6. Discussed possibly scoring different funding streams in different ways. This will be discussed at next year's scoring training.
- 7. It was discussed that we still need recommended funding caps for JAG, JJDP and VAWA.
